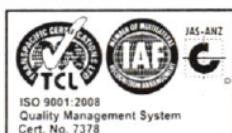

Telangana Marks National Sports Day with Grand Celebrations; Cash Awards to Athletes

Hyderabad TSIT BUREAU, August 29: Telangana on Friday celebrated National Sports Day with grandeur at Gachibowli Stadium, paying rich tributes to hockey legend Major Dhyan Chand. Sports and Youth Services Minister Vakati Srihari, speaking as chief guest, said Dhyan Chand's life and achievements continue to inspire generations of sportspersons. He urged athletes to aim for Olympic glory, drawing motivation from the hockey wizard who won three consecutive Olympic gold medals. The Minister said Telangana, under the leadership of Chief Minister A. Revanth Reddy, is committed not only to hosting Olympics in the future but also to ensuring the state's athletes emerge as medal winners. He noted that the new sports policy and government incentives are giving fresh impetus to athletes across disciplines. Sports Authority of Telangana Chairman Shiv Sena Reddy said that Telangana has set a benchmark by conducting nine days of



National Sports Day celebrations on an unprecedented scale, earning national-level appreciation. State Sports Advisor A.P. Jitender Reddy added that innovative programs were held across all district headquarters in addition to Hyderabad. As part of the celebrations, 41 athletes were presented with cash awards worth Rs.1.29 crore for their recent achievements at international and national tournaments. Notable recipients included World Archery U-21 gold medalist Chikita Taniparthi (Rs.5 lakh), powerlifter Shruti
