Pursuant to capital reduction Scheme as approved by the High Court judicature at Hyderabad, Telangana, on 22.06.2015, and certified true copy of the order dated 08.07.2015, Company had allotted 36 shares for every 100 shares and accordingly issued new Share certificates, and dispatched the new share certificate to the shareholders at their address registered with the Company among of which few returned undelivered. And further as per regulation 39 (4) of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, Company had sent three reminders letters to the shareholders at their address registered with the Company, whose share certificates returned back undelivered. Thereafter the said shares has been dematerialised due to no response from shareholders.
